Amendments from Voting Members; to be removed from *En Bloc*

Submission A

Submitted by: Rev. Susan Salomone [Upstate New York Synod, 7D]

Proposed:

That 5.01.e. be removed from *en bloc* for separate consideration by the ELCA Churchwide Assembly.

And that in the ELCA Constitution and all model constitutions, wherever the wording, “shall be persons of color and/or persons whose primary language is other than English” appears, add, “shall be all person(s) who are/is a member of a historically underrepresented group.”

Proposed:

That 5.01.e. and 12.41.11. be removed from *en bloc* for separate consideration by the ELCA Churchwide Assembly.

That 22.11.b. be removed from *en bloc* for separate consideration by the ELCA Churchwide Assembly.

And to amend 22.11.b. by striking “or a subsequent two-thirds of the members of the Church Council...[through the end of the paragraph].”

That 5.01.E19. be brought for consideration by the ELCA Churchwide Assembly.

And, in subcategory 5.01.E19., to include the goal of this church to be at least 20 percent of the voting members of Churchwide Assembly, Church Council, and churchwide boards and committees be youth and young adults.

And to amend 14.32.01. by striking “four-year” and inserting “three-year” (in its place).
