
ELCA Congregation Pulse Survey Overview

- The ELCA Congregation Pulse Surveys are an experimental effort to allow ELCA congregations and worshiping communities to communicate their perspectives, strengths, and development needs to synods and the churchwide organization.
- The July 2024 Pulse Survey was distributed to 1,835 congregations and worshiping communities. Key informants from 601 of these communities responded to the survey, for a response rate of 33%. Responses came from congregations and worshiping communities in 62 of 65 synods.
- Responding congregations and worshiping communities were largely representative of the ELCA
 in terms of average in-person worship attendance, community context, and racial diversity, though
 several small differences were observed. Responses were more likely to come from mediumsized congregations and from congregations slightly less diverse than the ELCA overall.

Familiarity with ELCA messaging on climate care


- Of the respondents to the July 2024 Congregation Pulse Survey, nearly half (42%) indicated most of their members were *not at all familiar* with the ELCA's social statement on creation care and the more recent social message on climate care. Only 2% of congregations reported that most members were *very familiar* with these documents.
- Familiarity differed somewhat by congregation size. Congregations with higher in-person attendance were most likely to report that their members were not at all familiar with these documents (55% of congregations with an average in-person worship attendance over 250).






Creation Care Actions Taken by Congregations

- Over two thirds of responding congregations (68%) reported taking some action to address creation care.
- When it came to intentionally working to reduce climate impacts, larger congregations (those with in-person attendance of more than 250 people) were nearly twice as likely (80%) as smaller and medium-sized congregations to intentionally work to reduce climate impacts (1-100 = 44%; 101-250 = 50%).
- Of the 117 congregations who specified other types of action, 41% noted some
 type of recycling and/or composting.




Presence of a creation care team

- Just over 1 in 10 respondents to the July 2024 Congregation Pulse Survey (13%) reported having an active team leading efforts for creation care. Nearly two-thirds of respondents (64%) do not currently have a team and are not planning to start one.
- Larger congregations (those with more than 250 in average in-person worship attendance) were twice as likely to have an active creation care team in place than smaller congregations (those with 100 or fewer).
- Rural congregations were less likely than urban or suburban congregations to have an active team leading creation care efforts, and less likely to be planning to start one.



Engagement with Creation Care


- Nearly one-quarter (23%) of responding congregations indicated their congregation's engagement with creation care has grown when compared to last year. Most (73%) indicated it had stayed the same.
- Respondents in suburban and urban congregations were more likely to report that their congregation's engagement with creation care had grown (either slightly or substantially) over the past year (37% and 30%, respectively), compared to rural congregations (14%).






Issues Impacting the Congregation's Community

- Half of responding congregations (56%) said more extreme weather events have impacted their community.
- Responses differed by the community context of the congregation.
 - Urban (74%) and suburban (63%) congregations more frequently reported being impacted by extreme weather events than rural (49%) congregations.
 - More than half (53%) of rural congregations reported their community was impacted by agricultural stressors, while urban and suburban reported being impacted at a far lower rate (20% and 15%, respectively).
- Approximately 1/3 of smaller congregations reported being impacted by agricultural stressors (1-100 = 33%; 101-250 = 30%). Larger congregations were unlikely to be impacted (5%).



What do congregations say they need?

- When asked to select what would assist their congregation in taking more action on creation care, two-thirds (66%) of respondents said educational materials for congregants.
- Respondents from larger congregations (over 250 in-person attendance) were considerably less likely to indicate need for resources.
 - Larger congregations were less likely to indicate they needed access to coaches, etc. (1-100 = 27%; 100-250 = 33%; Over 250 = 7%).
 - They were also less likely to indicate that knowing who the synod's resource person was would help them (1-100 = 33%; 100-250 = 38%; Over 250 = 14%).
