### ABOUT

Everyone in the United States has certain rights guaranteed under the U.S. Constitution, regardless of immigration status. Given the heightened levels of uncertainty and fear in communities, noncitizens and citizens alike may require even greater accompaniment and comprehensive support during this time and months ahead. Depending on someone's individual circumstances it may make sense to talk to a lawyer for more specialized assistance. ## Temporary Protected Status + Deferred Enforced Departure

<p><b>What is TPS?</b></p>	<p><u>TPS</u> may be designated by the Department of Homeland Security in cases of ongoing armed conflict, environmental disaster, or other extraordinary and temporary conditions which prevent individuals from safely returning home. Individuals must meet certain presence requirements but may be eligible to remain in the country during the designation period and obtain work authorization.</p>
<p><b>What is DED?</b></p>	<p><u>DED</u> allows foreign nationals to be protected from deportation and have the opportunity to work. DED is granted through the President’s foreign relations power. <i>These are the countries with active TPS designations: Afghanistan, Burma, Cameroon, El Salvador*, Ethiopia, Haiti*, Honduras, Nepal*, Nicaragua*, Somalia, South Sudan, Sudan, Syria, Ukraine, Venezuela, Yemen. Countries with TPS with a pending federal register notice: Lebanon. Countries with DED: Lebanon, Liberia, Hong Kong, Palestine.</i></p>
