EQUIPPING THE NEXT GENERATION OF LEADERS

The ELCA Fund for Leaders is the scholarship program of our church supporting students of tremendous promise who are attending ELCA seminaries as they prepare to become pastors and deacons. By making seminary more affordable, the ELCA Fund for Leaders enables more future ministers to go to seminary and helps them graduate with less debt, empowering those whom God calls into ministry to go and serve as the church needs and the Holy Spirit leads.

The ELCA Fund for Leaders was created by an action of the 1997 ELCA Churchwide Assembly, providing its first scholarships in 2000. Since then the program has supported over 1,200 qualified candidates with more than \$28 million in scholarship support.

Our alums — past recipients of scholarships — are now serving congregations and organizations across the ELCA and around the world. These pastors and deacons were able to accept calls where they were needed most, free from the concern of paying burdensome student loans.

The long-range goal for the ELCA Fund for Leaders is to provide full-tuition support for every candidate at an ELCA seminary. Currently, ELCA Fund for Leaders endowment funds have a combined value of \$80 million. Though we've come a long way since the Fund for Leaders was established, we still have a way to go before reaching our goal of the \$400 million needed to support all candidates for ministry at our ELCA seminaries.
